A RESOLUTION ESTABLISHING  
BUILDING PERMIT FEES AND FEES FOR APPLICATION FOR SPECIAL USE PERMITS  
FOR THE UNINCORPORATED  
PORTION OF AUDUBON COUNTY, IOWA

WHEREAS, Building Permit Fees and fees for Application for Special Use Permits for the Unincorporated Portion of Audubon County, Iowa, are to be set by the Audubon County Board of Supervisors by Resolution pursuant to Article 24, Section 2 and Article 22, Section 2 of the Audubon County Zoning Ordinance.

WHEREAS, the Board of Supervisors seek to seek and adjust said fees for the unincorporated area of Audubon County; and

NOW, THEREFORE, BE IT RESOLVED BY THE AUDUBON COUNTY BOARD OF SUPERVISORS that the building permit fees are hereby set, pursuant to Article 24, Section 2 of the Zoning Ordinance for the Unincorporated Portion of Audubon County adopted March 23, 2007, as provided in Exhibit "A" and the fee to accompany Special Use Permits for the Unincorporated Portion of Audubon County, Iowa is set in the amount of \$250.00.

BE IT FURTHER RESOLVED that this resolution shall be in full force and effect from and after its adoption/publication in the official Audubon County Newspaper.


This motion was introduced by Supervisor Venteicher, and seconded by Supervisor Nelson, and, upon roll call, was carried by an aye and nay vote as follows:


